Notification by Member of Pecuniary and Other Interests

GIVE NOTICE that I or my spouse or civil partner (or a person with whom I am living as husband and wife or as if we were civil partners¹) have the following

Disclosable Pecuniary Interests²

Employment

Any employment, office, trade, profession or vocation carried on for profit or gain. Any unpaid directorship.

Sponsorship

Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Contracts

Any contract made between the me or my spouse/partner (or a firm in which that person is a partner, or an incorporated body of which that person is a director* or a body that that person has a beneficial interest in the securities of*) and the council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

Land

Any beneficial interest in land which is within the area of the council. 'Land' excludes an easement, servitude, interest or right in or over land which does not give me or my spouse / partner (alone or jointly with another) a right to occupy or to receive income.

Licences

Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.

Corporate Tenancies

Any tenancy where (to my knowledge)—
(a) the landlord is the council; and
(b) the tenant is a body that I my spouse/partner is a partner of or a director* of or has a beneficial interest in.

Securities

Any beneficial interest in securities* of a body where—
(a) that body (to my knowledge) has a place of business or land in the area of the council; and
(b) either—
(i)) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body; or
(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I or my spouse / partner has a beneficial interest which exceeds one hundredth of the total issued share capital of that class.
